Upon your honor, gentlemen:

I, Anna Maria Riezinger, being duly declared and affirming this from without the United States per 28 U.S. Code 1746 (1) and under the penalties of perjury under the laws of the United States of America and from without the United States of America, declare to you individually and personally and in your capacities as Officers having limited delegated powers:

1. I am a natural-born national of the pre-Civil War state known as Wisconsin but not a citizen of the United States;
2. I claim my guaranteed exemptions from levies, taxes, and performances imposed on foreign citizens;
3. These same declarations have been lodged with your Offices since April 4th 1998 and are subject to disclosure;
4. The Municipal PERSON named after me, ANNA MARIA RIEZINGER, was surrendered to the U.S. Treasury Secretary (1789) and the U.S. Secretary of Treasury (1789) was named Trustee and made responsible for any bills or accounting related to the Municipal Corporation franchise dba ANNA MARIA RIEZINGER;
5. A private indemnity bond was similarly issued to protect me and my states from claims and charges related to the British Territorial Person(s)/Estates named after me, "Anna Maria Riezinger" and lodged with the Secretary of the Treasury (1789);
6. This serves as Notice to both your Offices that I have suffered attacks against my separate and original American person and full remedy, maintenance and restitution must be provided, including the return of my properties illegally seized upon by Municipal STATE TROOPERS feigning debt;



7. Clearly, any charges related to ANNA MARIA RIEZINGER should have been paid by the U.S. Secretary of the Treasury (1789);

8. Clearly, any charges related to the British Territorial Person/Estate dba “Anna Maria Riezinger” should have been covered by the Indemnity Bond AMR1 0001 RA 390 427 640 US;

9. Clearly, I, an heir and a Wisconsinite owed the guarantees of both existing Federal Constitutions have suffered disservice, neglect, and aggravated identity theft as well as illegal takings forbidden under both Federal Constitutions;

10. Clearly, I have been imposed upon to accept and administer public trusts and estates that I never volunteered to create and have been illegally and unlawfully coerced under force of arms to honor unconscionable contracts;

10. I am calling on both Marco Rubio and Scott Bessent to immediately correct and confirm all records related to “Anna Maria Riezinger” and to protect my person(s) and pursue my restitution as an American state national and advise your Agents of the same;

11. Upon completing the above performance to exonerate me from all federal presumptions and court actions, liens, fines, tax sales, etc., brought against U.S. Federal Citizens and United States citizens operated in my Name/NAME, I am calling upon Marco Rubio and Scott Bessent to further honor their service contracts by establishing a program and enabling state nationals to transact Mutual Offset Credit Exchange Exemptions promised to us as remedy under Federal Code Title 12, but never actually made accessible to the public;

12. The above facts are clearly demonstrated by thousands of pages of public records established over the course of three decades;

13. Your offices have failed to perform and failed to protect persons, including but not limited to me, who are contractually owed all the provisions of Article IV of both The Constitution of the United States and The Constitution of the United States of America;

14. Correction requires prompt action to permanently and retroactively identify me as an American state national, specifically, as a Wisconsinite, at peace with both the British Crown and the Holy Roman Empire since June 6th, 1956, owing no other performance, tax, tariff, duty or obligation of citizenship to either foreign government;

15. Finally, I wish to protest the harassment and execrable mistreatment that I and other American state nationals have suffered at the hands of the British Crown Officers and HRE OFFICERS who have been misunderstanding “accidentally-on-



purpose” our actual identity and genuine political status, so as to evade their own contractual obligations to us. This fails the good faith service requirements of their respective service contracts;

16. American state nationals are not “sovereign citizens” – which is a mindless oxymoron; American state nationals are instead “foreign sovereigns” with respect to the Administrations that Mr. Rubio and Mr. Bessent work for; those administrations are under contract to provide enumerated services including those clearly stated in Article IV of both remaining Federal Constitutions, requiring these men and their Offices, including Mr. Rubio and Mr. Bessent, to protect and defend our persons --- not impersonate us for their own profit;

17. The actual American Government to which I and most other Americans belong has been in Session for five (5) years and is not absent or in interregnum; during those five years, the remaining States of the Union organized prior to 1860 unanimously voted to enroll all the Territorial States created under the provisions of the Northwest Ordinance from April 1861 to October 1st 2020, so that all fifty non-insular States are now fully enrolled and recognized States of the Union, retroactive to the date that they entered any form of Territorial Statehood;

18. Read that: there are no longer presumed to be fifty-seven Territorial “States”. There are fifty (50) intact States of the Union represented by qualified and properly provenanced and declared State Citizens; and these States, which are instrumentalities of the free, sovereign, and independent Union States, have provided international and public notice of these facts for over five years;

19. All Federal Officers and Departments and Agencies owe me and the other remaining state nationals full cooperation and good faith service which has not been forthcoming and which has not been universally applied; the corrections required in my individual case(s) and accounts also apply across the board to all other state nationals who have been similarly misidentified as foreign persons and subjected to foreign forms of law in their own countries;

20. Upon completion of the correction of my identification records and balancing of my accounts and exoneration of all court actions and restitution of my property, so that no further claims of indebtedness remain, those assets held under my NAME are to be transferred from the U.S. Secretary of the Treasury (1789) Trusteeship to my direct ownership and the ownership of our unincorporated government, The United States of America (1777) --- and are otherwise to be held harmless:
